Concept III

"As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the AA General Service Board and several service corporations, staffs, committees and executives, and thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

In Concept III, we refer back to the Conference and General Service Board Charters, which describes the relation between the groups, the Conference, the Trustees and the active service units. Except for specific directions in these documents, every trusted servant and every AA entity, at all levels of service, has the right "to decide. . .how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises." Of course, this means that the Fellowship must have trust in their "trusted servants." We therefore "inform" rather than "instruct" our trusted servants. Additionally, Conference Delegates are primarily the world servants of AA as a whole and that only in a secondary sense do they represent their respective areas. Therefore, Bill states they should be able to cast their votes in the General Service Conference "according to the best dictates of their own judgment and conscience at that time."

There are ways to correct inefficiency, ineffectiveness, or abuse. If the Conference does not function well, the groups can send better Delegates. If the Trustees get out of line, the Conference can censure them, or even reorganize them. If our services need correcting, the Trustees can elect better directors and hire better help. Bill cautions us against using "the Right of Decision" as an "excuse for failure to make proper reports of actions taken; or for exceeding a clearly defined authority; or for failing to consult the proper people before making an important decision." Bill states "Our entire AA program rests squarely upon the principle of mutual trust. We trust God, we trust AA and we trust each other."

We were now at *Step Three*. Many of us said to our Maker, *as we understood Him*: "God, I offer myself to Thee to build with me & to do with me as Thou wilt. Relieve me of the bondage of self, that I may better do Thy will. Take away my difficulties, that victory over them may bear witness to those I would help of Thy Power, Thy love & Thy way of life." We thought well before taking this step making sure we were ready; that we could at last abandon ourselves utterly to Him *Alcoholics Anonymous* pg. 63.

Like all the remaining Steps, Step Three calls for affirmative action, for it is only by action that we can cut away the self-will which has always blocked the entry of God - or, if you like a Higher Power - into our lives. Faith, to be sure, is necessary, but faith alone can avail nothing. We can have faith, yet keep God out of our lives. Therefore our problem now becomes just how and by what specific means shall we be able to let Him in? Step Three represents our first attempt to do this. In fact, the effectiveness of the whole A.A. program will rest upon how well and how earnestly we have tried to come to "a decision to turn our will and our lives over to the care of God as we understood Him". Twelve Steps and Twelve Traditions, p. 40

Selfishness-self-centeredness! That, we think, is the ROOT of our troubles. Driven by a hundred forms of fear, self-delusion, self-seeking and self-pity, we step on the toes of our fellows and they retaliate. Sometimes they hurt us, seemingly without provocation, but we invariably find that at some time in the past we have made decisions based on self which later placed us in a position to be hurt.,,,, Alcoholics Anonymous pq. 62.

Established on such a footing, we became less and less interested in ourselves, our little plans and designs. More and more we became interested in seeing what we could contribute to life. As we felt new power flow in, as we enjoyed peace of mind, as we discovered we could face life successfully, as we became conscious of His presence, we began to lose our fear of today, tomorrow or the hereafter. We were reborn. Alcoholics Anonymous pg. 63.

Tradition Three

"The only requirement for AA membership is a desire to stop drinking."

Tradition Three:

- In my mind, do I prejudge some new AA members as losers?
- Is there some kind of alcoholic whom I privately do not want in my AA group?
- Do I set myself up as a judge of whether a newcomer is sincere or phony?
- Do I let language, religion (or lack of it), race, education, age, or other such things interfere with my carrying the message?
- Am I over impressed by a celebrity? By a doctor, a clergyman, and ex-convict? Or can I just treat this new member simply and naturally as one more sick human, like the rest of us?
- When someone turns up at AA needing information or help (even if he can't ask for it aloud), does it really matter to me what he does for a living? Where he lives? What his domestic arrangements are? Whether he had been to AA before? What his other problems are?

Tradition Three: Long Form

"Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation"

Greetings from Your Delegate

It's that time again! The 2017 General Service Conference Agenda items have been finalized and distributed! See your DCM if you have not received a copy. For those of you who are new to service, you may be asking "What's a General Service Conference, what do they do and why is it important"? To answer, let's look back: Many years ago, all matters important in Alcoholics Anonymous were handled by our co-founders Bill and Dr. Bob and a handful of non-alcoholic trustees. They worked together through the New York Headquarters to make all the decisions for Alcoholics Anonymous. But then Dr. Bob became critically ill. Everyone, especially Bill knew they were not going to live forever and something had to be in place to guarantee the future of Alcoholics Anonymous. Who was going to take care of Alcoholics Anonymous after they were gone? Would the growing number of AA groups trust a few unknown non-alcoholic men in some office in New York with the all of the business of Alcoholics Anonymous? How could these unknown nonalcoholic trustees act for us, but not really know what we needed or wanted? Thus the idea of a conference of Delegates from specific geographic areas (now numbering 93 Delegate Areas across the US and Canada) was born. Dr. Bernard Smith was a non-alcoholic friend of AA and one of the chief architects of the conference structure. Here I share perhaps 2 of his most convincing reasons for a conference structure: "we need it to ensure the recovery of a child being born tonight" and "we need it to ensure that changes in A.A. come only as a response to the needs and the wants of all A.A., and not of any few". Where do these items come from? In some way, shape, or form...they come from us! Some of the items on this year's Conference agenda include: CPC Committee: Consider development of a LinkedIn page for C.P.C. committees. Consider request that the title of the pamphlet "Is There an Alcoholic in the Workplace?" be changed to "Is There a Problem Drinker in the Workplace?" Corrections Committee: Discuss carrying the A.A. message to incarcerated Native American/First Nations/Inuit People. **Grapevine Committee**: Reconsider the 2004 Conference Advisory Action on outside sales. Discuss AA Grapevine. Inc.'s continued exploration of an Instagram account. Discuss AA Grapevine, Inc.'s. continued exploration of a Facebook page. Literature Committee: Review revised draft pamphlet "Finding Acceptance: A.A. for the LGBTQ Alcoholic" (formerly titled "A.A. and the Gay/Lesbian Alcoholic"). Review progress report on the development of literature for alcoholics with mental health issues and those who sponsor them. Review draft sample illustrations and corresponding revised text for the pamphlet "The Twelve Traditions Illustrated."Policy/Admissions Committee: Consider a request to add a "YPAA Subcommittee" to the service structure. PI Committee: Review report from the trustees' Public Information Committee on the Implementation of a Google for Nonprofits account and Twitter account. Treatment and Accessibilities Committee: Discuss the accessibility of the A.A. message for Armed Services veterans. From the **Archives Committee**: Consider proposal for a new publication, Unity in Action: Bill W.'s General Service Conference Talks, 1951 -1970 (working title). So to help prepare your Delegate, our Area holds a 'mock conference' where some of these agenda items will be covered 'committee style' just as it is done in New York.

This mock conference will be just part of the fun at the SWTA 68 Pre-General Service Conference Assembly in San Antonio April 7-9! Your input is necessary for shaping the most effective 'informed group conscience' of Alcoholics Anonymous as a whole. **Everyone** in attendance at the assembly who wants to participate in the mock conference gets to participate! So come join the fun! Thank you all for your service!

"Made a decision to turn our will and our lives our to the care of God as we understood Him."




And gradually, I felt God's presence as I learned to relax the control of my life. Nothing terrible was going to happen if things didn't go exactly the way I thought they should.


