### **Concept VII**

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

This concept attempts to clarify the relationship and "balance of powers" between the Conference and the General Service Board. It may appear to be contradictory. On the one hand, we see a board which is invested with complete legal power of A.A.'s funds and services; while on the other hand, the Conference has such great traditional influence and financial power that, if necessary, it could overcome the legal rights of the board. This means the practical power of the Conference will nearly always be superior to the board. The superior power is derived from the large majority of delegates in the Conference combined with, if necessary, the ability to deny the board with money with which to operate. Theoretically, the Conference is advisory only, but practically speaking has all of the ultimate rights and authorities it may ever need.

The Conference directs the board through recommendations (advisory actions) and the board carries out these recommendations. Though the board does have the legal authority to veto a Conference recommendation, it has never done so. Instead the trustees turn to qualified sources including the conference for advice or direction rather than turning to a veto. Part of the trustee's job is interpreting the laws as they apply to A.A. These legal rights help the trustees keep the business of A.A. running smoothly and legally so delegates can do the job they're supposed to do - help carry this message to the person who does not know there is a solution.

So, in concept VII, we address the practical authority given our trustees to ensure that the decisions of the Conference are consistent with the laws that govern us as well as the wellbeing of our fellowship as a whole. Our spiritual democracy is maintained by respect for the Conference's traditional authority backed up by the power of the groups. When the Conference acknowledges the rights, duties and legal responsibilities of the trustees, a harmonious and respectful working relationship can be maintained. Pam J.

"Indeed, the attainment of greater humility is the foundation principle of each of AA's twelve steps. For without some degree of humility, no alcoholic can stay sober at all. Nearly all A.A.s have found, too, that unless they develop much more of this precious quality than may be required for just sobriety, they still haven't much chance of becoming truly happy. Without it, they cannot live to much useful purpose, or, in adversity, be able to summon the faith that can meet any emergency."

"The Seventh Step is where we make the change in our attitude which permits us, with humility as our guide, to move out from ourselves toward others and toward God. The whole emphasis of Step Seven is on humility. It is really saying to us that we now ought to be willing to try humility in seeking the removal of our other shortcomings just as we did when we admitted we were powerless over alcohol, and came to believe that a power greater than ourselves could restore us to sanity. If that degree of humility could enable us to find the grace by which such a deadly obsession could be banished, than there must be hope of the same result respecting any other problem we could possibly have."

### "Every AA group ought to be fully selfsupporting, declining outside contributions."

- If GSO runs short of funds some year, wouldn't it be okay to let the government subsidize AA groups in hospitals and prisons?
- Is it more important to get a big AA collection from a few people, or a smaller collection in which more members participate?

### **Tradition Seven: Long Form**

The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

### Note From Your Delegate

Greetings District 12! I want to thank you again for inviting me to share the Delegate Report to your district. The conversations we shared afterward are what make these visits so enjoyable!

As I mentioned in the report, safety came up many times over the Conference week. The new service piece titled: *Safety in A.A.: Our Common Welfare* (SMF-209, it can be found on the aa.org website) includes the following: 'Safety is an important issue within A.A. — one that all groups and members can address to develop workable solutions and help keep our meetings safe based on the fundamental principles of the Fellowship. The piece goes on to state 'Alcoholics Anonymous is a microcosm of the larger society within which we exist. Problems found in the outside world can also make their way into the rooms of A.A. As we strive to share in a spirit of trust, both at meetings and individually with sponsors and friends, it is reasonable for each member to expect a meaningful level of safety. Those attending A.A. meetings derive a benefit by providing a safe environment in which alcoholics can focus on gaining and maintaining sobriety. The group can then fulfill its primary purpose — to carry the A.A. message to the alcoholic who still suffers. For this reason, groups and members discuss the topic of safety.'

More information from the service piece includes:

What Can Groups and Members Do? Groups and members can discuss the topic of safety, to raise awareness in the Fellowship and seek through sponsorship, workshops and meetings, to create as safe an environment as possible for the newcomer, and other members or potential members. This can be the subject of sharing among groups at the district or area level. Here are some helpful suggestions and reminders: • Talk about issues of safety before they arise. • Safety is something each member attending an A.A. meeting can be mindful of. • Communicate clearly what A.A. is and what it is not. • Sponsorship plays an important role and sponsors can be helpful in pointing out warning signs or unhealthy situations to sponsees and newcomers. • A.A. members who are concerned about the words or actions of a sponsor or other member, may find it helpful to speak to someone they trust, their A.A. group, or a professional, as needed. • Include Safety and the A.A. Meeting Environment as topics for a group inventory. • Consider developing group guidelines and procedures on safety. Recommend that no one walk to a car alone but be accompanied by a trusted fellow or travel in a group. • In all discussions about safety, keep the focus on our primary purpose, our common welfare, and place principles before personalities.'

We can't go wrong if we allow our Traditions to guide us! Several trusted servants in our Area have been giving workshops to groups and districts on this topic of safety. Feel free to reach out anytime!

### "Humbly asked Him to remove our shortcomings."


Coming into AA and finding the acceptance and love I'd sought in a bottle was a relief beyond description, but reading the Steps was a shock. Fortunately for me, my home group did not hammer the Steps into newcomers. Rather, they talked a lot about the Slogans and the need to not drink a day at a time. I needed that.

During a discussion of Step Seven, I made the statement, "If my shortcomings and character defects are removed, there will be nothing left!" I need not have feared. What I've learned since then is that I have more than a lifetime's supply of character defects. My Higher Power and I can't get rid of them all in my allotted time on this earth.


More importantly, I've learned that if I simply let go of a character defect--release it--my Higher Power will replace it with a character asset. As I release anger I find that I am friendlier. As I release hate I become more loving. As I release fear I become more secure. I don't have to go out looking for friendliness, love, security, or any other trait that I desire. I just have to give up the feelings that are manifestations of my character defects and the good automatically flows into my life. . . . And I used to think that I would become hollow without my character defects!

So, how does it work? Daily. On a daily basis I choose not to drink--or to fear, hate, be angry, or indulge in any other defect that's raising its ugly head. They're all there waiting, and when given a chance they charge into the center of my life and try to take over. But when I work Step Seven I find that my life is filled with good, and people actually like to be around me--something they never did in my drinking days.


