Tradition 5

Each group has but one primary purpose--to carry its message to the alcoholic who still suffers.

Have you ever gone to an AA meeting and felt like you just walked into a therapy session? The principles of our fellowship tells us that we are to carry the message to those who still suffer from Alcoholism. As our world has changed and more and more people are coming into our meetings, are we doing a good job carrying the message to the alcoholic or are we allowing issues other than alcohol to become a major part of our meeting? Most all of us have had other issues, but as Bill W. states in the 12 x 12, "Shoemaker, stick to thy last" do one thing supremely well than many badly."

It was through sponsorship that I learned how to chair a meeting. It was suggested that I be prepared and have a topic from the Big Book or 12 X 12 ready if I was asked to chair. There are those occasions when I am asked to chair a meeting at the last minute. My sponsor told me to open the book and read a paragraph or go with the groups guided suggestions for meetings. It was instilled in me to chair a meeting from the literature of AA. By sticking with this idea, I do my best to chair a meeting that carries the message to the still suffering alcoholic.

Early in my recovery, I had been going to meetings and met a woman who had asked me to sponsor her. She told me that she thought she was more of an addict but she could relate to what I said in the meetings so we were going to try to work as sponsor and sponsee. As we began the process of reading the Big Book and talking about our experiences with our disease, we realized that we were coming from different experiences. Even though working the steps may be the same, she told me that she just could not relate to what I was saying. This is the same as with the meetings. I do not get much out of the meeting if I cannot relate to the experiences of the people sharing. I need to stay with alcoholics and the program of Alcoholics Anonymous.

Let us stay with what we do best!
Carry the message to the alcoholic who still suffers!

More Pioneer Women of A.A.

Marty Mann wrote the second edition Big Book story, "Women Suffer Too." She was the first female A.A. member to achieve lasting sobriety. She attended meetings in Bill and Lois' home at 182 Clinton Street in Brooklyn, New York. She was a patient of Dr. Harry Tiebout who had given her a multilith copy of the Big Book. She pioneered a group in Greenwich, Connecticut and became a personal friend of Bill and Dr. Bob. She founded the National Committee on Education of Alcoholism which later became the National Council on Alcoholism.

Agnes Mayo was the sister of Fitz Mayo an early A.A. member in New York City. She loaned Works Publishing Company \$1000 to help pay the printer costs for publishing the Big Book.

Florence Rankin wrote the first edition Big Book story, "A Feminine Victory." She entered A.A. on September 13, 1937. She was the only female A.A. member when possible names for the Big Book were discussed. It was because of her that the Big Book could not be named, "100 Men." She was the first female drunk to stay at Bill And Lois' home in Brooklyn. She returned to drinking and died April 19, 1943 of an apparent suicide.

Lilian Roth was a popular singer who went public in the 1940's about her alcoholism and her membership in A.A. She wrote her story in the book, "I'll Cry Tomorrow," which was later made into a movie. She helped get A.A. started in Australia.

Henrietta "Henri" Seiberling was the daughter-in-law of Akron tire giant Frank Seiberling and a good friend of Anne Smith. She was a non-alcoholic member of the Oxford Group. She was the last on a list that Reverend Walter Tunks gave to Bill Wilson when Bill Called from the Mayflower Hotel in May of 1935. Henrietta arranged for Bill and Dr. Bob to meet on Mother's Day, May 12, 1935 at her home, the gatehouse behind the main house of Frank Seiberling.

Anne Ripley Smith was the wife of A.A. co-founder Dr. Bob Smith. They were married in 1915. She attended Oxford Group meetings as early as 1932 and convinced Dr. Bob to go with her. In early 1936 she organized a wives group. Bill Wilson called her "The Mother of A.A." She talked with Sister Ignatia just about every day and they both helped Akron's first alcoholic women. She and Sister Ignatia and Henrietta Seiberling taught Bill and Dr. Bob the importance of a daily "quiet time" of prayer and reflection.

Kay Stewart and her husband KC got sober in 1965 and she remained sober until Founder's Day weekend of June 5, 2003. She, KC, Oscar Futral and about five other A.A.s used to meet for breakfast at the Flame Restaurant in Akron. It became a regular A.A. morning meeting with over 150 home group members. She is best known for working with Wesley Parrish from Pompano Beach, Florida to form the Founders Foundation to purchase

the former home of Dr. Bob and Anne Smith at 855 Ardmore Ave. With the help of many other A.A.'s they were able to repair and restore the home. Today it is on the State of Ohio Historic Registry and the National Historic Registry.

Lois Burnham Wilson was the wife of A.A. co-founder Bill Wilson. From the beginning of A.A. she helped alcoholics as well as the wives and families of alcoholics. She was cofounder of Al-Anon and was active all her life in serving that fellowship as well, traveling and speaking extensively in the US, Canada, and around the world until she died in 1998 at the age of 97. Her picture appeared in the Jack Alexander March 1, 1941 Saturday Evening Post article.

Nell Wing was a non-alcoholic secretary and assistant to Bill Wilson working at the General Service Office from March 1947 until 1982 when she retired. She was the secretary for AA World Services Inc. and the first AA archivist starting in 1973 to about 1983 but began her archival work in 1957. At the A.A. International Convention in Seattle, Washington in 1990. Nell was given the ten millionth copy of the big Book. She was on the Lear Jet that rushed Bill Wilson from Bedford Hills, NY to the Miami Heart Clinic on January 24, 1971.
