What it means to be a DCM

The district committee member, or DCM, plays a vital role in general service. While the GSR is the voice of a group, the DCM is the voice of a district. A district needs a leader. The GSRs will look to the DCM for guidance on being GSRs and serving their groups. They will look to the DCM to lead on forming an agenda for district activities. They'll want to be inspired and encouraged, but not told what to do.

A DCM who can set their own opinions aside in favor of listening and supporting the district's GSRs and of understanding and advancing the conscience of the district's groups is practicing two important principles of leadership in A.A.: leading by example and serving with humility.

The DCM learns the thoughts, wishes and needs of the district's groups in different ways. Many districts set aside time in their meetings for GSRs to give reports on what's happening in their groups. This gives the DCM the opportunity to listen, to ask questions and to make suggestions (and to follow up to see if the suggestions helped).

The DCM also learns by visiting and communicating directly with the

groups. Here, the DCM is serving as a resource — and not as a replacement for a GSR. In a group without a GSR, the DCM may be able to open a line of communication. Sometimes this stimulates interest within the group to want a GSR of their own.

What the DCM learns will eventually form the conscience of the district. As a member of the area committee, at area assemblies the DCM has the opportunity to express the district's conscience in more than one way:

- By asking questions and making suggestions on area business and proposing new ideas, perhaps for a new way to carry our message of recovery or a potential revision to a piece of A.A. literature.
- By conveying the district's conscience to the delegate on issues coming before the annual General Service Conference, the DCM can help to make the district's conscience part of the delegate's thinking.
- By voting on the area's trusted servants, including the delegate position, and the area's activities and budgets.

What it means to be a DCM

Duties and Responsibilities

Every district is different, but the following are relatively common service activities undertaken by DCMs:

- 1. Regularly hold district meetings. DCMs are asked to give reports to the GSRs on news, issues, proposals and future events from the area and G.S.O. It is also important for DCMs to keep the GSRs informed about Conference activities, perhaps even assisting the delegate in reporting theproceedings of the General Service Conference, either by organizing report-backs or delivering the reports to their districts in lieu of the delegate. GSRs are typically asked to report on what's happening in their groups, and DCMs can make sure that GSRs have what they need in order to assure good communication across the service structure.
- 2. Regularly attend area assemblies. The number of assemblies during the year varies by area. All DCMs (and GSRs) from around the area are asked to attend. DCMs (and GSRs) are voting members of these assemblies.

- 3. Reach out to groups in the district that do not have GSRs. Some groups may have little or no history of electing GSRs. Some may have had active GSRs in the past, but no longer. The DCM is asked to open a line of communication with these groups. The purpose is not to badger them into electing GSRs, but to begin to connect them to A.A. as a whole.
- 4. Organize workshops and/or sharing sessions on service activities.
- 5. Bring Traditions problems to the attention of the delegate.
- 6. Help GSRs become acquainted with The A.A. Service Manual/Twelve Concepts for World Service. DCMs can also be helpful by introducing the GSRs to Box 4-5-9 and service material from G.S.O., which includes workbooks and guidelines on an array of topics.
- 7. Alert the district's GSRs to new literature, service materials and technology applications from G.S.O. and Grapevine. This includes new books

- published by A.A. World Services and the Grapevine. The literature catalogs of the two corporations are an excellent resource. DCMs often hear about new literature before it appears in the catalog, and it can be helpful to alert GSRs on what's coming. The groups may have questions and comments on these. The DCM can help the GSRs address these while also passing them along to the area and the delegate.
- 8. Assist the delegate in obtaining group contact information for A.A. Regional Directories. These directories are used for A.A. purposes only. They include information on individual groups by city within each province or territory, with contact information on group contacts.
- 9. In many areas, DCMs attend area committee meetings in addition to area assemblies. The purpose and scheduling of these meetings varies by area.

Tradition of the Month

Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.

This Tradition is packed with meaning. For A.A. is really saying to every serious drinker, "You are an A.A. member if you say so. You can declare yourself in; nobody can keep you out. No matter who you are, no matter how low you've gone, no

matter how grave your emotional complications—even your crimes—we still can't deny you A.A. We don't want to keep you out. We aren't a bit afraid you'll harm us, never mind how twisted or violent you may be. We just want to be sure that you get the same great

chance for sobriety that we've had. So you're an A.A. member the minute you declare yourself."

Concept of the Month

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

The Conference and General Service Board Charters in broad terms define the responsibility of the Conference to act on behalf of A.A. as a whole. In these two documents a necessarily large area of delegated service author-

ity and responsibility has been staked out. These instruments, in a general way, describe the relation between the groups, the Conference, the Trustees and the active service units. These broad definitions and descriptions are an indispensable frame of reference, and we could not function without them.

July, 1970, eleven thousand members of Alcoholics Anonymous meeting in Miami Beach, Florida, made the following pledge in eleven different languages:

A Declaration of Unity

This we owe to A.A.'s future: To place our common welfare first; To keep our fellowship united. For on A.A. unity depend our lives; And the lives of those to come.

The acceptance of this declaration at the 1970 International Convention of A.A. put a final seal of approval on a decades-long campaign by co-founder Bill W. to establish the preservation of unity as a priority to assure A.A.'s future. Twenty years earlier, at the first International Convention, in Cleveland, several thousand members had voted to accept the Twelve Traditions, which Bill had written and advanced for the express purpose of assuring that A.A. would survive as a society. The formal Declaration of Unity at the Miami Convention gave this added force. Why was such a statement necessary? Almost from the very beginning of A.A., Bill had focused on the importance of maintaining Unity in the Fellowship. By working together, we could achieve and maintain sobriety that had eluded us when we were alone. Even when A.A. had less than a hundred members, most of them concentrated in New York and Akron, Bill and Dr. Bob had a vision of a unified fellowship that could reach out to alcoholics throughout North America and even the world. In Bill's own talks and writings, he always emphasized the need to preserve unity in order to maintain sobriety for ourselves and preserve A.A. for "the million who still do not know." In introducing the Traditions, Bill had written, "So long as the ties which bind us together prove far stronger than those forces which would divide us if they could, all will be well.... We shall be secure as a movement; our essential unity will remain a certainty." What were the forces that could divide A.A.? Bill often mentioned such issues as the struggle

for property, power and prestige. He felt it absolutely necessary that A.A. as a society should avoid controversies over politics and religion. He believed anonymity was also a factor in maintaining unity, and that A.A.'s assistance should be available to everybody without favor or prejudice. Bill had first described the Twelve Traditions as "Twelve points to assure our future." He viewed these as being essential for the preservation of the society, just as the Twelve Steps are essential for the recovery of the individual member. A.A.'s most challenging concern, he had written, "was to preserve among A.A.'s such a powerful unity that neither weakness of persons nor the strife and strain of these troubled times can harm our common cause. We know that Alcoholics Anonymous must continue to live. Else, save few exceptions, we and our brother alcoholics throughout the world will surely resume the hopeless journey to oblivion." Bill was ailing and had less than a year to live when the formal Declaration of Unity was adopted. Though attending the Convention in a wheelchair and appearing briefly on the platform, he was unable to make a major address as he had at past Conventions. But it surely must have given him a surge of pride to have this declaration endorsed by the Convention, just as the 1965 International Convention in Toronto had formally issued the Declaration of Responsibility. According to information in the A.A. Archives, the declaration was probably authored by Al S., the same A.A. member and consultant who had composed the Responsibility Declaration. It also reflects the efforts of the committee that worked on the 1970 International Convention (which was A.A.'s 35th Anniversary). The theme for the Convention was, appropriately, "Unity Within Our Fellowship." At the Convention's Saturday night ceremony, Bob H. (who was G.S.O. general manager at the time) summoned several ex-delegates and overseas members to be on stage to participate in adopting the declaration. "A.A. unity is the special quality that makes our Fellowship unique," Bob said. "It is the cement that holds our society together, the platform which makes A.A. 'Service' possible. It is more than an agreement on basic principles, more than freedom from destructive strife. It is a bond fashioned of shared experience, such as this one we share tonight. Unity is our most precious possession, our best guarantee of A.A.'s future. May we all value and preserve it, today and all the tomorrows to come." Bob H. then asked all participants on stage to recite the Unity Declaration, which was led by Dr. Jack Norris, the nonalcoholic trustee and chairman of the General Service Board. Bill's deteriorating health kept him from attending the Saturday night meeting, but he made it to the stage the next morning for a fourminute talk that brought a standing ovation. This, in Bill's final months, was poignantly reminiscent of Dr. Bob's brief talk at the 1950 Cleveland Convention, when he urged us to remember that the Twelve Steps resolve themselves into love and service, his last message before he died that fall.

The power of prayer and meditation: Peggy and her husband were visiting Corpus and wanting to relocate there from Michigan. Not sure their house would sell to afford their relocation Peggy awoke in the middle of the night, woke her husband up at 3am and had him take her to the beach to pray and meditate. She meditated and prayed asking her Higher Power, "Do You want us here or back up north? ".The next week they had an offer on the house. Answer to prayer!

Every morning I pray and meditate and every night I work the 10th step. I never miss morning meditation, it centers me

To the newcomer...sit down, shut up, and listen.

People in AA will teach you what to do and what not to do by example.

I listen in meetings, it's like being sponsored.

At 3 years sober I worked for a treatment facility, I was the 1st female driver. I spent many hours on the road picking people up at the airport or wherever. What a wonderful opportunity I had sharing AA, my experience, strength, and hope with these new comers.

When I lost my husband to MS in 2014 the first person I called was my sponsor. She came and stayed with me for 2 days. I never thought of drinking. Jerry, my husband had 11 years more sobriety than me.

I can share anything due to working the 4th and 5th steps.

Working the steps create a change.

I came into AA through Alanon. Alanon taught me to hate the disease not the person.

December 1944 From A.A. Grapevine Points of View

Dear Mother of "J.": I cannot tell how poignantly I am stirred by the letter you wrote The Grapevine about your alcoholic son.

Just ten years ago my own mother, after years of frantic bewilderment, lost hope. Long a chronic problem drinker, I had come to the jumping-off place. A very good doctor had pronounced the grim sentence: "Obsessive drinker, deteriorating rapidly-hopeless."

The doctor used to talk about my case somewhat like this: "Yes, Bill has underlying personality defects. . . great emotional sensitivity, childishness and inferiority.

"This very real feeling of inferiority is magnified by his childish sensitivity and it is this state of affairs which generates in him that insatiable, abnormal craving for self approval and success in the eyes of the world. Still a child, he cries for the moon. And the moon, it seems, won't have him!

"Discovering alcohol, he found much more in it than do normal folks. To him alcohol is no mere relaxation; it means release-release from inner conflict. It seems to set his troubled spirit free."

The doctor would then go on, "Seen this way, we normal people can picture how such a compulsive habit can become a real obsession; as indeed it has, in Bill's case. Once he arrived at the obsession point, alcohol overshadows all else. Hence he now appears utterly selfish. And immoral. He will lie, cheat, steal or what have you, to serve his drinking ends. Of course those about him are shocked and dismayed because they think his actions are willful. But that's far from being so. The real picture of Bill is that of a bankrupt idealist; one who has gone broke on vain, childish dreams of perfection and power. Victimized now by his obsession, he is a little boy crying alone in a dark strange room; waiting agonized for mother--or God--to come and light a candle." I must confess, Mother of "J.," that I may have put some of these words into the doctor's mouth. But that's the alcoholic's life as I have lived it.

Did I, an alcoholic, have a defective character? Of course I did. Was I, an alcoholic, also a sick man? Yes, very.

To what extent I was personally responsible for my drinking, I don't know. Yet I'm not one to take complete refuge in the idea that I was a sick man only. In earlier years I certainly had some degree of free will. That free will I used badly, to the great misery of my mother and countless others. I am deeply ashamed.

As one who knows me a little, you may have heard how, ten years ago, a friend, himself a liberated alcoholic, came to me bearing *the light* which finally led me out of the toils. There will come a day like that for you and yours--I'm so confident!






