#### <u>Tradition of the Month</u>

With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.

This Tradition is packed with meaning. For A.A. is really saying to every serious drinker, "You are an A.A. member if you say so. You can declare yourself in; nobody can keep you out. No matter who you are, no matter how low you've gone, no

matter how grave your emotional complications—even your crimes—we still can't deny you A.A. We don't want to keep you out. We aren't a bit afraid you'll harm us, never mind how twisted or violent you may be. We just want to be sure that you get the same great

chance for sobriety that we've had. So you're an A.A. member the minute you declare yourself."

#### Concept of the Month

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

The Conference and General Service Board Charters in broad terms define the responsibility of the Conference to act on behalf of A.A. as a whole. In these two documents a necessarily large area of delegated service authority and responsibility has been staked out. These instruments, in a general way, describe the relation between the groups, the Conference, the Trustees and the active service units. These broad definitions and descriptions are an indispensable frame of reference, and we could not function without them.

#### I Am Responsible

It was written for the 1965 AA International Convention in Toronto. In an article titled, 'How I am Responsible became a part of AA', from the GSO newsletter, Box 4-5-9. The article identifies former AA trustee, Al S. as the author of the Responsibility Statement.

In the souvenir book for the 1965 Convention, Dr. Jack Norris writes:

"...We must remember that AA will continue strong only so long as each of us freely and happily gives it away to another person, only as each of us takes our fair share of responsibility for sponsorship of those who still suffer, for the growth and integrity of our Group, for our Intergroup activities, and for AA as a whole.

It is in taking responsibility that real freedom and the enduring satisfactions of life are found. AA has given us the power to choose — to drink or not to drink — and in doing so has given us the freedom to be responsible for ourselves. As we become responsible for ourselves, we are free to be responsible for our share in AA, and unless we happily accept this responsibility we lose AA. Strange, isn't it?"

In a Grapevine article in October 1965, the Responsibility Statement is discussed, and Bill W. expresses his views:

Two major thoughts stood out in the remarks of the many speakers, alcoholic and nonalcoholic, at AA's July Toronto Convention. The first was admiration and gratitude for AA's startling success in sobering up hundreds of thousands of lostcause drunks. The other was concern that the success

which has come to AA over the thirty years since its start in Akron, Ohio in 1935 would not lead us to any complacency about the size of the job still to be done.

The theme of the Convention was: Responsibility.

"I am responsible. . . when anyone, anywhere, reaches out for help, I want the hand of AA always to be there. And for that: I am responsible."

AA's co-founder, Bill, in his talk to over 10,000 attending the major sessions of the Convention, stressed the need for cooperation with all who work on the problem of alcoholism, the more than 100 agencies in the United States and Canada alone now engaged in research, alcohol education and rehabilitation.

"Too often, we have deprecated and even derided these projects of our friends just because we do not always see eye to eye with them," Bill said. "We should very seriously ask ourselves how many alcoholics have gone on drinking simply because we have failed to cooperate in good spirit with these many agencies. No alcoholic should go mad or die merely because he did not come straight to AA in the beginning."

"The first concern of AA members should be with problem drinkers the movement is still unable to reach," Bill said. He estimated that there are 20 million alcoholics in the world today, five million in the U.S. alone. "Some cannot be

reached because they are not hurt enough, others because they are hurt too much," he declared.

"Many sufferers have mental and emotional complications that seem to foreclose their chances. Yet it would be conservative to estimate that at any particular time there are four million alcoholics in the world who are able, ready and willing to get well if only they knew how. When we remember that in the 30 years of AA's existence we have reached less than ten per cent of those who might have been willing to approach us, we begin to get an idea of the immensity of our task and of the responsibilities with which we will always be confronted."

There have been two Advisory Actions from the General Service Conference regarding the Declaration of Responsibility since it was introduced. In 1971, the Conference recommended that:

The Literature Committee, following the general feeling of the Conference, reaffirm both the spirit and the wording of the "I am Responsible" Declaration from the International Convention held in Toronto in 1965.

And in 1977, the Conference recommended that: The Responsibility Declaration not be changed, as it was made at the 1965 International Convention in Toronto.

#### An Interview with Bill Holloway Sobriety Date September 1st, 1991

After treatment I had a short stay at the Arc on the south side of San Antonio. I was told The Winner's Club needed a custodian. I went to work at the Winner's Club making \$70.00 a week as the custodian. I was really the janitor, but custodian sounds better. I opened up the club, made coffee, kept up the snack bar, and cleaned up at night. They gave me a free room to sleep.

An old timer walked up to me one day and he said, you know you're gonna look back at this time here as the best time in your sobriety. I thought that was a strange thing to say but it really was the best time in my sobriety. it gave me so much being around so many sober people.

My sponsor is Jim Willis, he is 93 years old with 67 years of sobriety. He's been my sponsor since I was 2 years sober. I asked him after hearing him tell his story at the Winner's Club. We worked the steps on drugs & alcohol, then later on rage & jealousy, then on how to get along in the work place without wanting to strangle people.

I probably go to 4 to 5 meetings a week, I just love the fellowship, I need people. I need to be around people. I learned early on that's where the power was, in the people. I spent my whole life thinking that all these people were my problem and it turned out that they were my solution. Just like the book says, what's the substitute well the substitute is fellowship.

Real early in my sobriety my sponsor told me to talk to the new guy. I started doing prison meetings at almost 2 years sober . It's the best 12 step work I've ever done. I have been in the past the District 12 CFC Chair.

I always say my sobriety date when I share because my first 2 sponsors always did. I was told to try and find humor in what you share, the newcomer needs to hear that. If you share some humor with your story people will better be able to see that you've overcome that from your past and you have joy about it. I think that's real important.

To the newcomer: What connected me to the group was the service, get involved with the home group. Find out what they're doing. Carry the message with others, share your experience, strength, and hope.

You've got to work the steps to find out to find what it is about you that keeps you falling short. Don't hesitate working the steps. I was on the 9th step at 4 months sober. That's very important.

I tried to sober up for 18 months, but I kept trying to drink. I wasn't working the steps wasn't being honest with anybody I was just there to get out of trouble and trying to find a girlfriend. I did it for the wrong reasons but the weight became so heavy I couldn't carry it any more. I couldn't pretend like I didn't care anymore, couldn't hide that loneliness in my eyes, that fear .

My wife and I were told she had stage 4 breast cancer that had metastasized and she probably had 2 years maybe. That's not something I believe you can take on your own. The big book calls it unaided will power. What we both did was turn it over to God, we said God you got this. So we got busy with life. We turned it all over to God. We kept praying about it. Today she is cancer free and has been for 10 years at least. She went through surgery, chemo, and radiation. I went to the doctor after he told us the cancer was gone and asked him if he thought all that prayer cured her? The doctor grined and said, well that plus the medicine. I believe in blessings and miracles, I've seen a lot of them.

The first guy I sponsored just celebrated 30 years last j\January. I was thinking about him one day 20 years ago so I called him. He asked why did you call me? I told him I was thinking about him. Mario says my dad is dying. That wasn't a coincidence ... The Big Book calls it Tapping into an unsuspected unknown inner resource. I've had that resource and didn't know it.

I always give my last name Bill Holloway I want you to be able to find me.

I was in prison the first time in 1980 for a year and I got out. I didn't stay on my parole so they arrested me and sent me back. I was doing the same thing. They were trying to send me back for the third time, I was doing the same thing. Then a miracle happened. I was in a treatment center and every day I was asking God to help me, that if I had to go back I wanted Him to help me make it all right. I wanted to be able to accept it.

My attorney told me I was going back at least for 10 years, you're a repeat offender. My day in court my attorney said, "you're not going to believe what's happening here, the special prosecutor that's so hard on repeat offenders is on vacation and the judge who's court this is and has it in for repeat offenders, he's called in sick today, and that judge up there will sign anything we put in front of him, and that girl up there is my best friend in the DA's office. We made a deal for you for 3 years probation". I believe that was God working in my life.

Something I heard Bill say in a meeting ... "Willingness is the key but Action is the magic word."

#### Dr. Bob's Farewell Talk

My good friends in A.A. and of A.A.,

... I get a big thrill out of looking over a vast sea of faces like this with a feeling that possibly some small thing I did a number of years ago played an infinitely small part in making this meeting possible. I also get quite a thrill when I think that we all had the same problem. We all did the same things. We all get the same results in proportion to our zeal and enthusiasm and stick-to-itiveness. If you will pardon the injection of a personal note at this time, let me say that I have been in bed five of the last seven months and my strength hasn't returned as I would like, so my remarks of necessity will be very brief.

There are two or three things that flashed into my mind on which it would be fitting to lay a little emphasis. One is the simplicity of our program. Let's not louse it all up with Freudian complexes and things that are interesting to the scientific mind, but have very little to do with our actual A.A. work. Our Twelve Steps, when simmered down to the last, resolve themselves into the words "love" and "service." We understand what love is, and we understand what service is. So let's bear those two things in mind.

Let us also remember to guard that erring member the tongue, and if we must use it, let's use it with kindness and consideration and tolerance.

And one more thing: None of us would be here today if somebody hadn't taken time to explain things to us, to give us a little pat on the back, to take us to a meeting or two, to do numerous little kind and thoughtful acts in our behalf. So let us never get such a degree of smug complacency that we're not willing to extend, or attempt to extend, to our less fortunate brothers that help which has been so beneficial to us.






